# AT MONTLAKE LIBRARY

It may be the last thing on your mind, but maybe you've given some thought to death.

Wendi Lindquist certainly has. Her presentation, "Red, White, and Dead: Death and Dying in the Pacific Northwest, 1774-1844," will examine the rituals and cultural understandings of death and dying. She'll describe how different cultures "practiced" death, its causes, body preparation, funerals, sites of interment, mourning, and concepts of an afterlife. Beginning with the arrival of European and American explorers in the late eighteenth century, she will discuss how regional death practices evolved as natives and newcomers were forced to adapt to new economic, environmental, legal, political, and religious changes. Jackie Williams will introduce Wendi.

Wendi Lindquist was born near Portland, grew up loving the Pacific Northwest and its history, but in college set out to study diseases and immunology. Inspired by a great history professor, she decided to combine disease with history. She graduated from Carleton College and is currently a sixth-year graduate student in the University of Washington's history department. She is an editorial intern for *PNQ* and graduate assistant for the Center for the Study of the Pacific Northwest. Her dissertation, "Death and Dying on the Northwest Coast of North America, 1774-1858" shall be written, as it must be, in deathly prose.

The meeting is at the Montlake Branch Library located at 2401 24th Ave. East. The time is 5:30pm on Tuesday February 9th. The library is about eight blocks south of Husky Stadium.
